

**University System of Georgia: BlueChoice HMO Plan**



The Summary of Benefits and Coverage (SBC) document will help you choose a health plan. Will you pay less if you use a <u>network provider</u> ?	Yes, BlueChoice HMO. Call the number on the back of your ID card for a list of <u>network providers</u> . Do you need a <u>referral</u> to see a <u>specialist</u> ?	Yes.	This <u>plan</u> will pay some or all of the costs to see a <u>specialist</u> for covered services but only if you have a <u>referral</u> before you see the <u>specialist</u> .
