

**University System of Georgia: Graduate Student Plan**

<b>What is not included in the <u>out-of-pocket limit</u>?</b>	Any fourth quarter deductible amounts carried over from previous benefit period, <u>Prescription Drugs</u> , <u>Premiums</u> , <u>balance-billing</u> charges, and health care this <u>plan</u> doesn't cover.
